

# **Measurement and Reporting Update**

MNCM's Measurement and Reporting Committee (MARC) recently reviewed and approved the charters for two projects related to strategic priorities set forth by the Board of Directors. The Measure Review and Prioritization (MRP) subcommittee is tasked with evaluating MNCM's current processes and developing recommendations to revise and modernize the way MNCM approaches its measurement work. Specifically, the Measure Review and Prioritization process will establish how MNCM sets short and long-term priorities for measures to be used in MN, evaluates the measure set for appropriate balance of measures, incorporates a health equity lens, and considers distinctions for measure use.

As part of the strategic priority to prioritize health equity by embedding in all areas of work, a Social Risk Factor Technical Advisory Group (SRF TAG) will be convening this spring to explore the technical aspects of incorporating social risk factor data (e.g., housing instability, food insecurity, transportation, etc.) into the data collection process. The SRF TAG is tasked with developing a roadmap outlining the necessary steps for the incorporation of SRF data elements by 2025.

#### **Future of Measurement: National Landscape**

Presented by Michelle Schreiber, CMS, Deputy Director, Center for Clinical Standards and Quality; Director, Quality Measures and Value Based Incentives Group, Centers for Medicare & Medicaid Services

The national landscape in quality measurement continues to evolve, with major entities like the Centers for Medicare and Medicaid Services (CMS), the National Committee for Quality Assurance (NCQA) and others making shifts to emphasize outcomes over processes of care, consolidate the number of measures used, and address health equity through selection of measures and by collecting data to better understand health disparities. This session will feature Dr. Michelle Schreiber, Deputy Director of the Center for Clinical Standards and Quality for the Centers for Medicare and Medicaid Services (CMS) and the Group Director for the Quality Measurement and Value-Based Incentives Group at CMS. Dr. Schreiber will speak about CMS priorities for measurement and how they fit into its broader vision of improving health care nationwide.
