Letter from MNCM President and CEO Julie Sonier

Greetings,

Greetings, and happy summer! This is my favorite time of year, both because of the warm weather and the longer daylight hours to get outside and enjoy it. I hope you have some exciting adventures planned for the summer.

This edition of MNCM's quarterly newsletter provides updates on a variety of happenings and projects at MNCM, and I want to share my perspective on two of them in particular:

First, it was so gratifying to be able to gather in person this year for MNCM's Annual Conference on April 26. There was an energy in the air that just can't be achieved via Zoom! Among the many topics covered were some important projects MNCM has under way that aim to build on our foundational work of collecting and publishing data on health care quality,

cost, and equity in some important ways – by enabling research to better understand what works to improve outcomes and care, by providing new information to drive quality improvement efforts, and by addressing barriers to data sharing between health care providers and payers. I especially want to thank all of the conference speakers, sponsors, exhibitors, and MNCM staff who made the day a success!

Second, MNCM is making rapid progress in transitioning to the new PIPE data collection system for clinical data. In the clinical data collection cycle for Measurement Year 2022 that wrapped up in March, 53 percent of patients were submitted via PIPE (up from 28 percent the previous year). I want to recognize the medical groups that have already onboarded to PIPE and those that are currently in the onboarding process for their engagement and commitment.

When I talk with peers from outside of Minnesota, they often express awe at what we have been able to accomplish here through collaborative efforts such as the work of MNCM. The two examples above are important reminders that MNCM's success depends on the efforts of many partners and collaborators.

MNCM Data Validation

Thank you to medical groups that completed 2022 Measurement Year (MY) data submission. MNCM is currently in the process of risk adjusting quality measures (where applicable), and will share the one-week risk adjustment preview of final results with medical groups later this summer. In total, 27% of medical groups submitted through PIPE (73% DDS) and 53% of patients were submitted through PIPE (47% DDS).

MNCM is currently prioritizing PIPE onboarding for large primary care groups and multi-specialty health systems. We anticipate that over 70% of medical groups and 85% of patients will be submitted through PIPE in 2023 MY. The remaining specialty groups and small clinics will complete onboarding early in 2024 for 2024 MY submission.



MNCM Dynamic Tables Tool Shifts to Member, Supporter Acces

MNCM's Dynamic Tables tool is now available for MNCM health plan members, supporting members, and mission supporters only. Medical group and clinic-level data for quality and cost measures will continue to be publicly available through the *appendices* to MNCM's published reports and the medical group and clinic profiles published via *MNHealthScores*.

Dynamic Tables will now be found in the *MNCM Data Visualization Portal*, where members can access interactive tools, including the Member Benchmarking Tool.

Minnesota Health Care Disparities By Insurance Type Report

Results for care delivered in 2021

Gaps in health care quality for people with coverage through Medical Assistance and MinnesotaCare compared to other types of health insurance persisted in 2021, according to a new report from MN Community Measurement (MNCM). The report was prepared for the Minnesota Department of Human Services and compares health care quality and health outcomes for people who received coverage through Minnesota Health Care Programs managed care organizations (MHCP MCO) to the same measures for people with private health insurance coverage or Medicare Advantage plans. The report includes 21 measures of health care quality for preventive care, chronic disease management, and mental health.

Social Risk Factors Data Collection

March 22, 2023

Collection and use of data on social risk factors to improve health outcomes and health equity is currently a high priority in Minnesota and nationally, and the landscape is evolving rapidly. In 2022, MN Community Measurement convened a Technical Advisory Group (TAG) to develop a roadmap for future collection of social risk factors data. The TAG's main goals were to find a way of collecting information on social risk factors that:

- Accommodates providers' use of multiple approaches and tools,
- Avoids creating additional burden for providers, and
- Will be robust and adaptable as national approaches and expectations evolve.

This webinar summarized the TAG's work and recommended roadmap for MNCM to begin collecting social risk factors data by 2025.

Health Care Quality in Minnesota: Disparities by Insurance Type

May 23, 2023

As the health care system continues to recover from the impacts of COVID-19 on care delivery, quality measurement provides valuable insights into a variety of health topics that continue to have opportunities for improvement across Minnesota.

In this installment of MNCM's Health Care Quality webinar series, MNCM provided an overview of the *Minnesota Health Care Disparities by Insurance Type Report*. This report was completed in collaboration with the Minnesota Department of Human Services (DHS) and includes analysis of statewide results segmented by Minnesota Health Care Plans (MHCP) and Other Purchasers (e.g, commercial, Medicare). Additionally, statewide results by the MHCP population are further segmented by Race, Ethnicity, Language and Country of Origin (RELC). The webinar also featured insights from DHS, including how they utilize this report in their work towards quality health care for Minnesotans.
