MNCM Board of Directors Welcomes New Member

MARC Explores COVID-19 Impact on Measurement, Seeks Community Input

To better understand the impact of COVID-19 on quality care and measurement, MNCM gathered input from the Measurement and Reporting Committee (MARC) during its June meeting. Among topics discussed were how care delivery and direct patient care have changed, the impact of COVID-19 on health care disparities, patient/provider barriers, opportunities in collecting and reporting data, and more.

With guidance from MARC, MNCM is seeking further input from community stakeholders regarding considerations for data collection and reporting for 2020 dates of service. Please complete this *three-question survey* to share your perspective. The survey will close on July 31, 2020.

PIPE Implementation Advances as Medical Groups Near Completion of Pilot Testing

In 2019, MNCM introduced a new approach and system for data collection called *PIPE (Process Intelligence Performance Engine)* that is intended to make data submission much easier and allow for more timely feedback on performance throughout the year. MNCM is pleased to share the news that pilot testing of the new PIPE data standards and technologies is nearing completion. Testing has included data file upload and import processes as well as measure calculations in the new Performance Engine (PE). Measure results calculated in PE are compared to the results that were calculated in MNCM's current Direct Data Submission (DDS) system. Calculations for two screening measures (Colorectal Cancer Screening and Adolescent Mental Health and/or Depression Screening) were tested first, and results were found to be comparable to DDS. Testing of the remaining measures is expected to be complete by the end of July, and the system will be moved into full production late this summer. MNCM will notify Minnesota clinics when they can begin making the switch from DDS to PIPE. Both systems (DDS and PIPE) will be available for 2021 reporting. *Contact us* to learn more.

» 2019 Minnesota Health Care Disparities by Insurance Type

The MNCM and DHS Disparities by Insurance Type report presents statewide and medical group rates of performance on quality measures for patients in Minnesota Health Care Programs (MHCP). It also includes differences in rates of care provided by medical groups between patients insured through MHCP and those insured through other forms of health care insurance, such as commercial or Medicare-managed care.

» 2019 Minnesota Health Care Disparities by Race, Ethnicity, Language and Country of Origin

This report features information on health care outcomes in several areas, including Optimal Diabetes Care; Optimal Vascular Care; Optimal Asthma Care for Adults; Optimal Asthma Care for Children; Colorectal Cancer Screening; and more. Results for these measures are stratified by race, Hispanic ethnicity, preferred language, and country of origin (RELC) and reported at statewide and regional levels.
